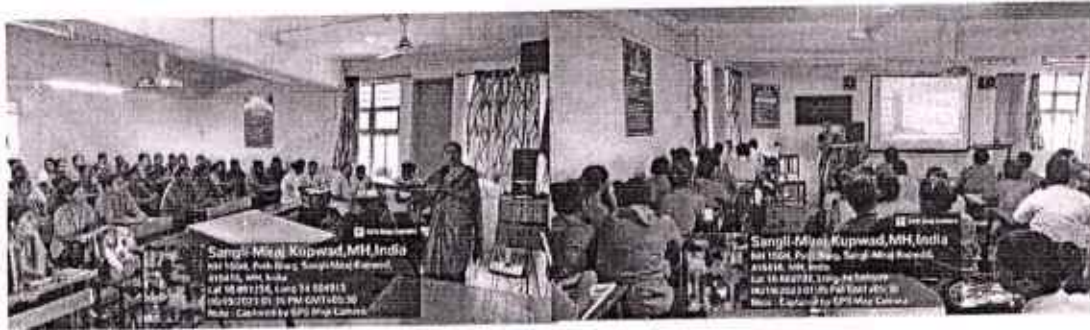
*Mrs Manisha Kale* conducted Session on Protect her from sexual harassment of women at work place, Human rights commission, Commission for women.

- Encourage students to engage in policy advocacy to contribute to positive change in these areas.



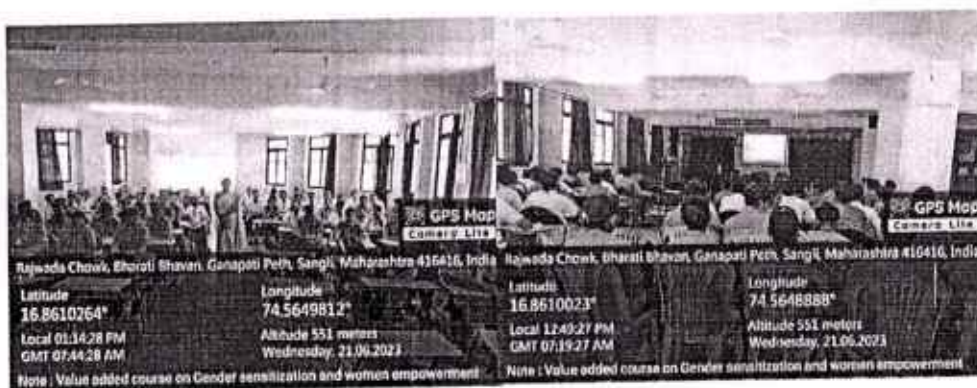
*Mrs. Geetanjali Deshmukh* conducted Session on Dowry death and honour killing.

- **Understand legal framework:** Familiarize students with the provisions and mechanisms of the PCPNDT Act, including its implications for medical professionals, clinics, and individuals seeking prenatal diagnostic services.
- **Analyze enforcement and challenges:** Explore the role of the judiciary in enforcing the PCPNDT Act, examining landmark judgments and legal precedents related to the Act, and discussing the challenges faced in its implementation.





- **Promote women's welfare:** Highlight the significance of the judiciary in protecting and promoting the welfare of women, ensuring their rights, and addressing issues such as gender-based discrimination, violence, and reproductive rights.
- **Engage in legal discourse:** Encourage students to critically analyze the role of the judiciary in interpreting and shaping laws related to women's rights and welfare, fostering an understanding of the intersection of law, justice, and gender.
- **Advocate for legal reforms:** Inspire students to engage in discussions and advocacy efforts for legal reforms that protect women's rights, improve the implementation of the PCPNDT Act, and address gaps in the judicial system concerning women's welfare.



*Hon,ble Mr Pravin Nardele, Secretary, DLSA, Sangli* was invited as Chief Guest and Resource Person for Role of Legal Service Authority to provide Legal Aid and Justice to women victims.

#### Objectives of the Session: -

- **Legal Awareness:** Educate women victims about their legal rights and entitlements, ensuring they are aware of the legal remedies available to them. This includes knowledge of laws related to women's rights, such as those pertaining to domestic violence, sexual harassment, dowry, divorce, and inheritance.
- **Access to Justice:** Promote equal access to justice for women victims, regardless of their socioeconomic background. The Legal Services Authority works towards removing barriers that may prevent women from accessing the justice system, such as lack of information, financial constraints, or fear of societal stigma.
- **Legal Aid:** Highlight the provision of free legal aid and assistance to women victims who are unable to afford legal representation. The Legal Services Authority offers support through legal professionals, including lawyers and paralegals, who provide guidance, advice, and representation to ensure that women victims receive fair and adequate legal assistance.
- **Empowerment:** Empower women victims by equipping them with knowledge and skills to navigate the legal system independently. This includes educating them about their rights, the legal processes involved in seeking justice, and the resources available to them for support.
- **Rehabilitation and Support:** Address the holistic needs of women victims by connecting them with other support services beyond legal aid. This may involve





referring them to counseling, medical assistance, shelter homes, and rehabilitation programs to ensure their overall well-being and recovery.



The course concluded with a film screening of "THAPPAD" followed by a discussion panel consisting of Dr. P. P. Narwadkar, Mr. Sanjay Aher, Mrs. Manisha Kale, and Mrs. Pratima Kumbhare.

### Course Outcome

5. **Empowerment and self-confidence:** A course on women empowerment helped nursing students develop a sense of empowerment themselves. They gain confidence

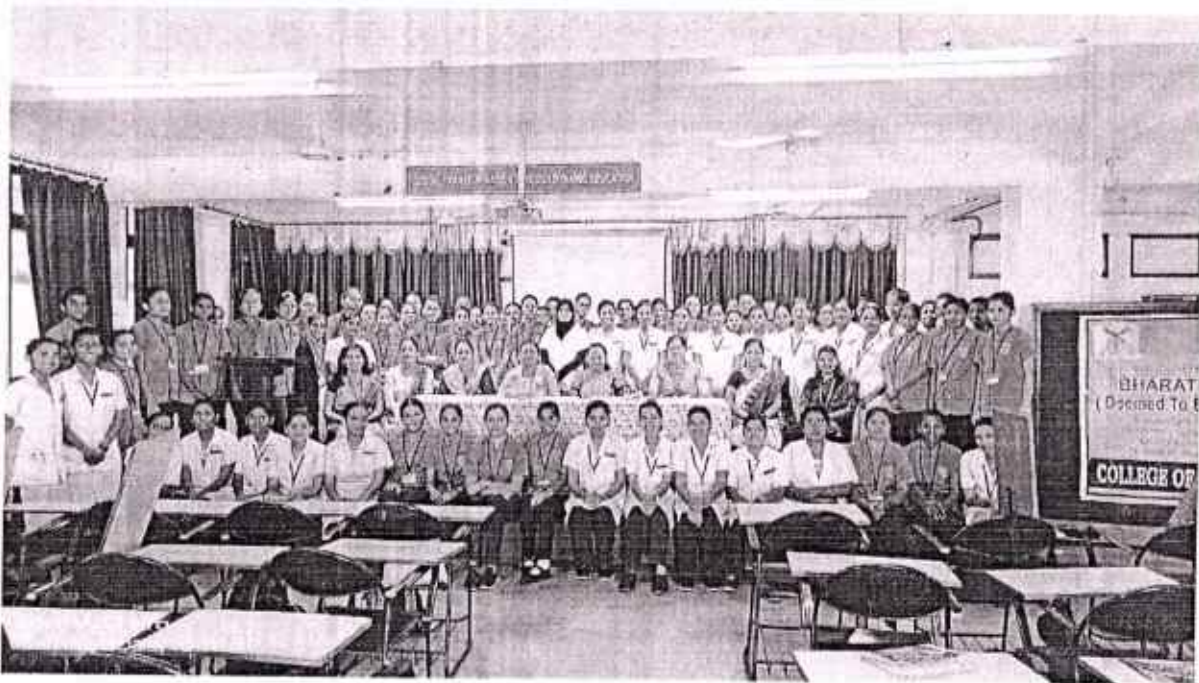




in challenging gender norms, advocating for women's rights, and actively promoting gender equality in their personal and professional lives.
