Date: 21/06/2021

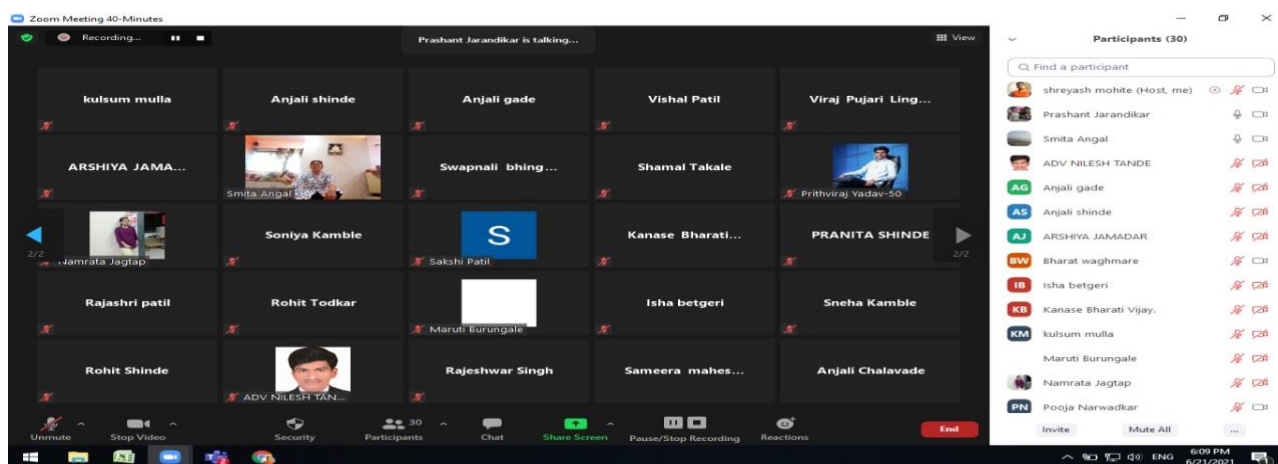

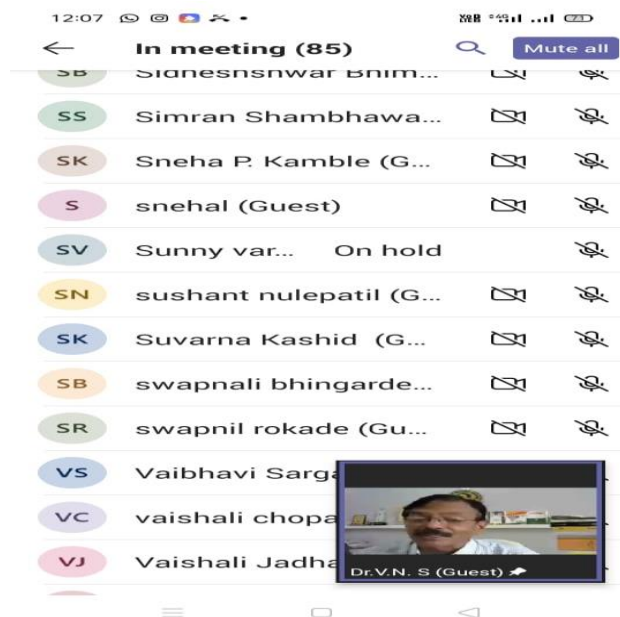

The webinar was arranged by the NSS wing of the college on Monday, 07/19/2021. All the NSS volunteers were present for the webinar. The chief guest of the webinar was **Dr. V. N. Dr. V. N. Shinde sir explained us one remarkable experience from Shivaji University. He explained that how the Shivaji University has become self-reliant about the water. It has its own water system. They don't have to pay a single rupee to Municipality. Otherwise the water bill of the university would be in minimum 10Lakhs. Now due to building of some lakes at university and conserving the water it provides the more than sufficient water to hostels both boys and girls. He told us that due to the conservation of water not only the ground water level of the university area has increased but also of the surrounding area of the university campus.

Which Lok Adalat to be Approached

As per section 18(1) of the Act, a Lok Adalat shall have jurisdiction to determine and to arrive at a compromise or settlement between the parties to a dispute in respect of -

(1) Any case pending before; or

(2) Any matter which is falling within the jurisdiction of, and is not brought before, any court for which the Lok Adalat is organised.



National Lok Adalat

National Level Lok Adalats are held for at regular intervals where on a single day Lok Adalats are held throughout the country, in all the courts right from the Supreme Court till the Taluka Levels wherein cases are disposed off in huge numbers.

National Level Lok Adalats has been organized throughout the country from the Supreme Court till Taluka level court for the following dates on Saturday, 12th March 2022, 7th May 2022, 13th Aug 2022 and 12th Nov. 2022.

Orientation program

Orientation program has been organized on the Lok Adalat for the students of classes LL.B. I, II, III & Pre III, IV, V on the 10th Mar 2022 at 10:30 am to 12:30pm.

Objectives:

- 1) Reduce anxiety,
- 2) Help students to understand organization's expectations, and
- 3) Orientation is a chance for students to get acquainted with actual workings of lok Adalat



Students entered court rooms they observe procedure of Lok Adalat. Various matters discussed over there student noted down the points regarding issue involved, discussion over the matters, settlement point and conclusion. Before a break time Presiding Judge and other jury members were introduced the ideology behind the Lok Adalat and Honble judges enlightened to students on what are the cases come under the Lok Adalat & what is its importance in Present Scenario. Students asked the queries and Judged and the other members were satisfied the queries.

Observations of Lok Adalat by students

There are various issues which raised during Lok Adalat proceedings. The most important factor while deciding the cases at the Lok Adalat is the finality of the Award. The award passed by the Lok Adalat is the decision of the court itself though arrived at by simple method of conciliation instead of the process of arguments in court. Cases can be decided by the Mutual consent of the parties. It cannot be forced on the part that matter has to be decided by the Lok Adalat.

The benefits that litigants derive through the Lok Adalat are :

- No Court Fee
- Procedure Flexibility and Speedy Trial
- Directly interaction with the Judge
- Award of Lok Adalat is binding



Conclision

The Lok Adalat proceeding was very conducive to seeking amicable resolution to disputes and saved the parties the cost of litigation. Experience of such extracurricular activity brought extra knowledge to the law students. The purpose of the visit was to understand the working of court, the nature of duties of the Judicial Officers in the matters of Lok Adalat, to observe how the concept of conciliated settlement of dispute works, General Procedure followed in the Lok Adalat, Jurisdiction exercised by the Lok Adalat and the nature of cases that are referred to the Lok Adalat for settlement is achieved. Students participated in this Visit Program, learned various Aspects of Lok Adalat .

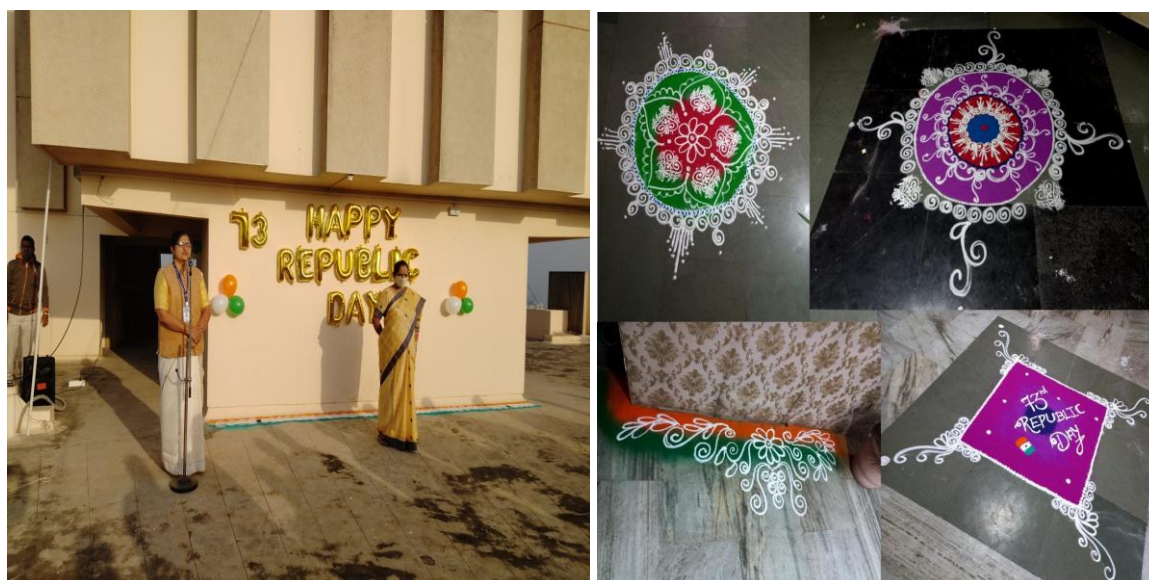
At the end of the street play our students allotted pamphlets to the public. The pamphlet provided all the information relating to Legal services Authority which our students demonstrated through their street play.

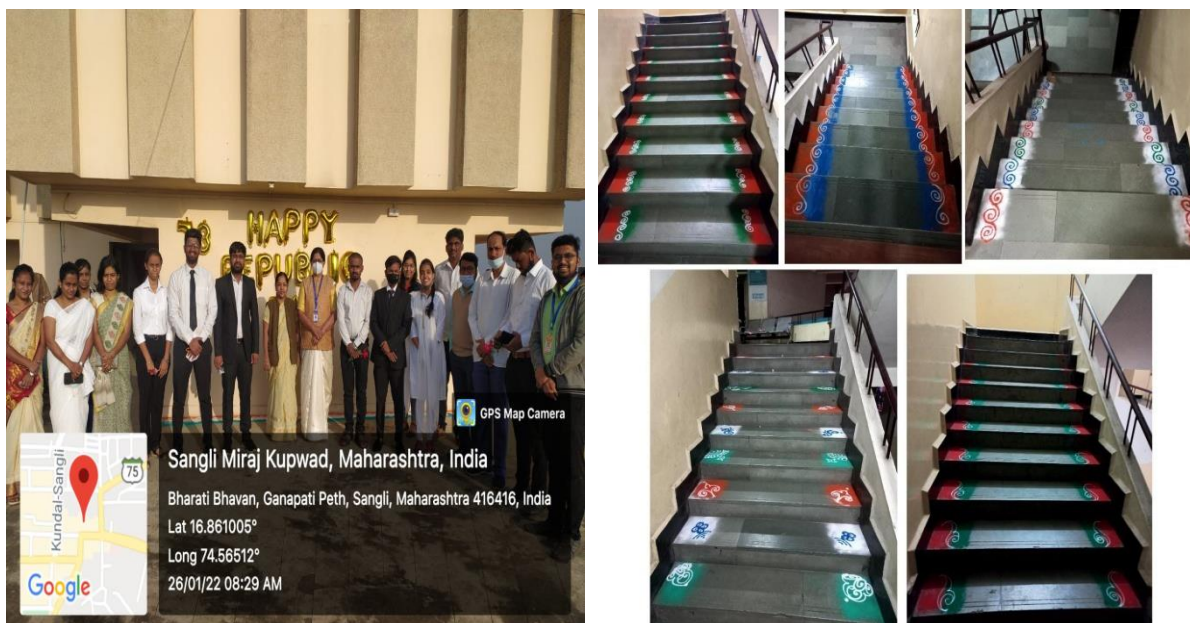


The day was celebrated in our college with great eclat. The college building was tastefully decorated with rangoli, balloons, flowerpots and national flags. We were beside ourselves

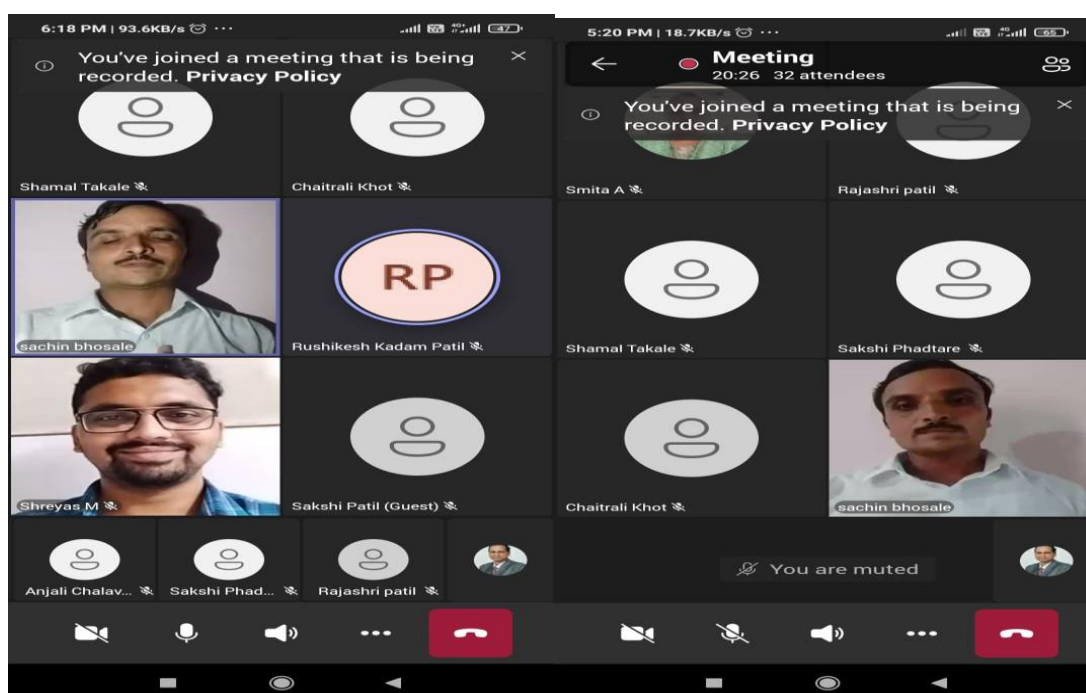

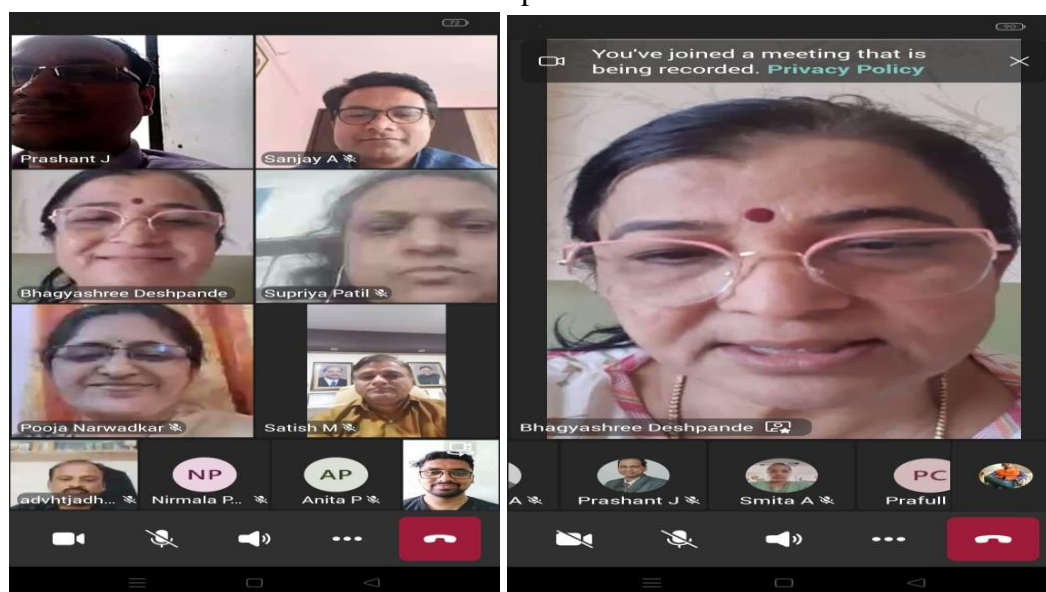

How to write Synopsis or Research Proposal?

The second session of the lecture series on research skills jointly organized by Bharati Vidyapeeth's, New Law College Sangli, Yashwatrao Chavan Law College Karad and New Law College Kolhapur, under Faculty Development Program was held on Saturday ,26th March , 2022. Topic of the session was 'How to write Synopsis or Research Proposal?' .The session was conducted in virtual mode. Dr. Bhagyashree Deshpande, Ex-Principal of Bharati Vidyapeeth's New Law College, Pune, was invited as a resource person.

At the beginning, Dr . Mahendra Khirnar faculty of Yashwatrao Chavan Law College Karad welcomed and introduced the resource person.



Dr. Deshpande, in her eloquent style explained the topic ‘How to write synopsis?’ elaborately. She emphasized that ideal synopsis should include all the aspects like: title of research or thesis, introduction of 2-3 pages, literature review, objective of your work and hypothesis, methodology or your work plan, bibliography or references and conclusion including the scope and limitations of your study. She advised that the title of the synopsis should be as concise as possible. It must occur consistently in every respect, including punctuation, capitalization, and hyphenation, on the abstract and approval forms. Further, she added that introduction shall justify and highlight the problem poser and define the topic and the aim and scope of the work presented in the synopsis. She told synopsis may also highlight the significant contributions from the investigation. Review of Literature shall present a critical appraisal of the previous work published in the literature pertaining to the topic of the investigation. The extent and emphasis of the Literature shall depend on the nature of the investigation.

In question answer session Dr. Bhagyashree Deshpande clarified the doubts of the participants. Prof. Preeti Deshmukh from Yashwatrao Chavan Law College Karad delivered vote of thanks.

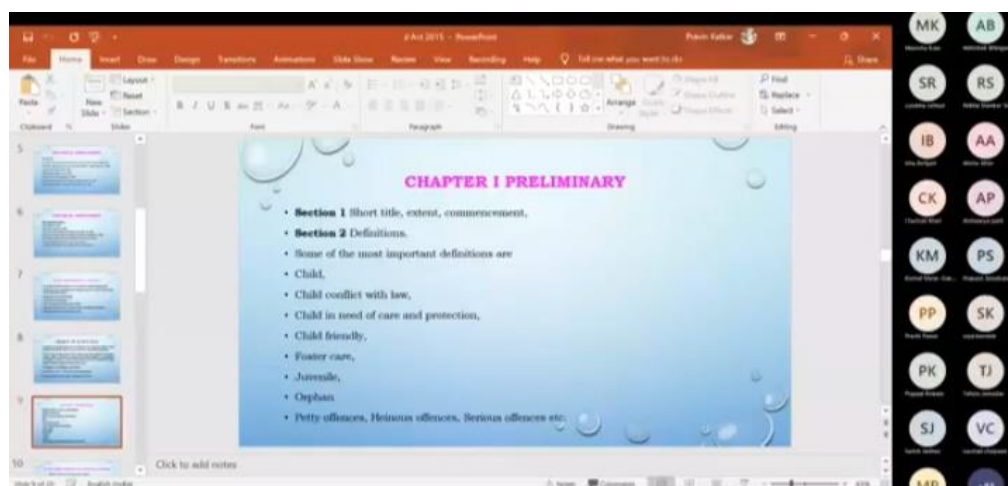

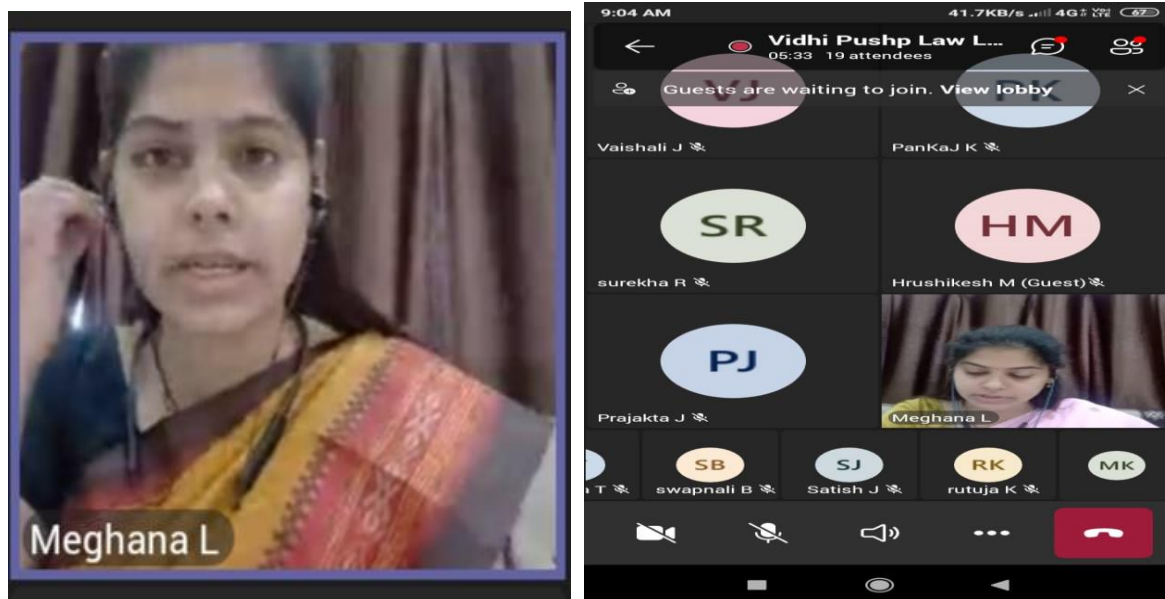

Lecture on Accountancy for lawyers

There are online sessions in lockdown of Vidhi Pushp Law Lecture Series. It is conducted by the practicing lawyers, active social workers, Advocates, psychiatrist, medical sector or corporate training centers etc.

This is what the 2nd lecture conducted by the college in the academic year 2021-22 under VIDHI PUSHP LAW LECTURE SERIES. Such session is guided by Adv. Meghana Joshi [company secretary], on 22nd October at 9:00 a.m. and on 23rd October at 9:00 a.m. in two consecutive sessions for the students of LL.B I and Pre Law III year. About more than 50 students and faculty members participated for such lectures.

The lecture was started at 9:00 a.m. with the welcome address by Prof. Manisha Kale and she introduced the guest.



Later on Adv. Meghana started the session and gave information as why accountancy is important to learn and study? Though it is not a subject of law students, why it is introduced in law subject and for law professionals? While answering the question she said, "being a professional there are some rights and some duties too, towards court, society, profession, client and opponents etc". To fulfill monetary duty towards government as well as to pay tax is an important duty towards society as a being an advocate. Further she explained accountancy helps to maintain day to day dealings as a professional is it either profitable or occur losses etc. While session she introduced the concepts of accountancy as the role played by accountant; what is Book Keeping? The objectives, importance and principles of book keeping; the basic features of accountancy; meaning and advantages of double entry book keeping. While concluding the first day session she explained the types of accounts.

In the second session that is on 23rd she revised in short the 1st session. Further she explained the terms of Classification of Accounts, Journal Entry, Ledger Posting and universally accepted rules of Debiting and Crediting; and she further stated the term of subsidiary book, what it includes?; Rules of Cash Book applicable to large scale, small scale, medium scale etc. While explaining the part she gave various examples to understand the concepts.



As she said, being a professional who is eligible to pay tax have to prepare profit and loss account and for that have to maintain account of income and expenditure. Later on in same session she showed the specimens of journal entry, balance sheet, profit and loss account etc. She cleared all the doubts of students in question and answers session and she concluded the lecture. All the students of LL.B.III & Pre-law V attended lecture offline and remaining students joined lecture online with the help of link shared on college whats app groups.

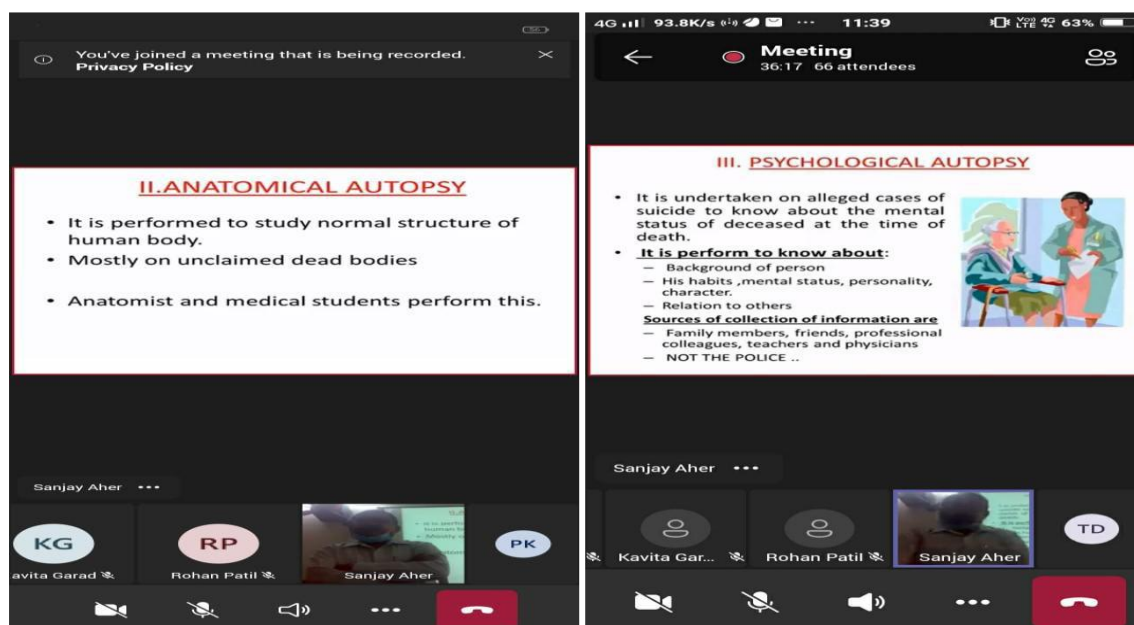


Total 40 students and 6 teachers attended offline and 66 students and 4 teachers joined in online mode.

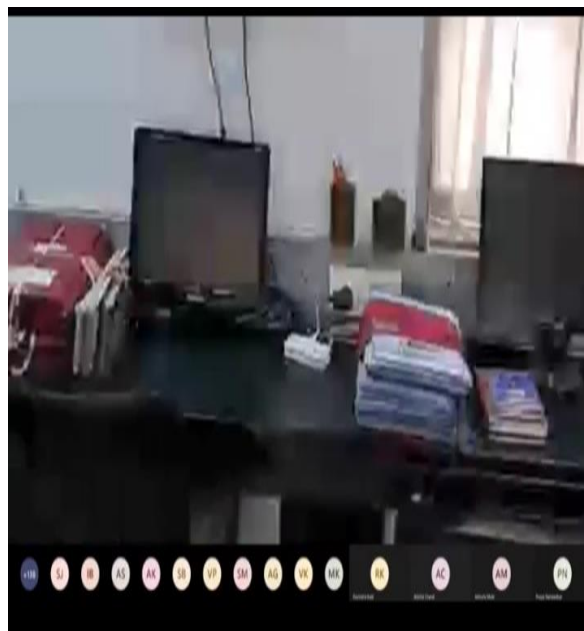


Adv. Mustaf Shamim interacting with the students

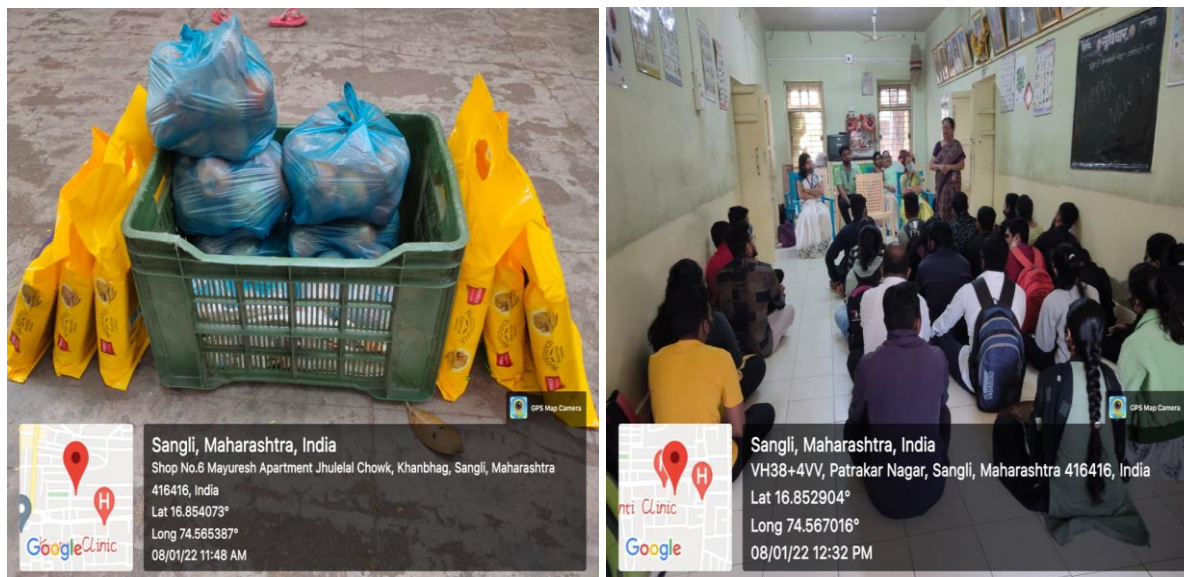
We were taken by surprise as there were more number of children than we had imagined. There was a common room where the children from the ages of 3 to 21 years were seen.

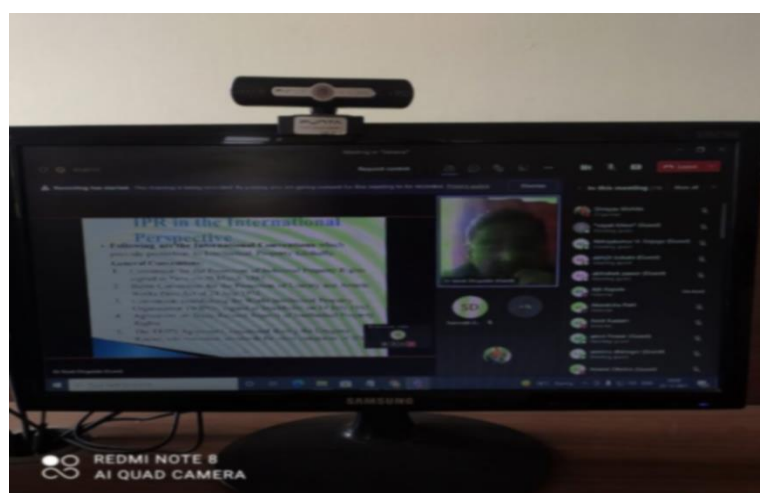

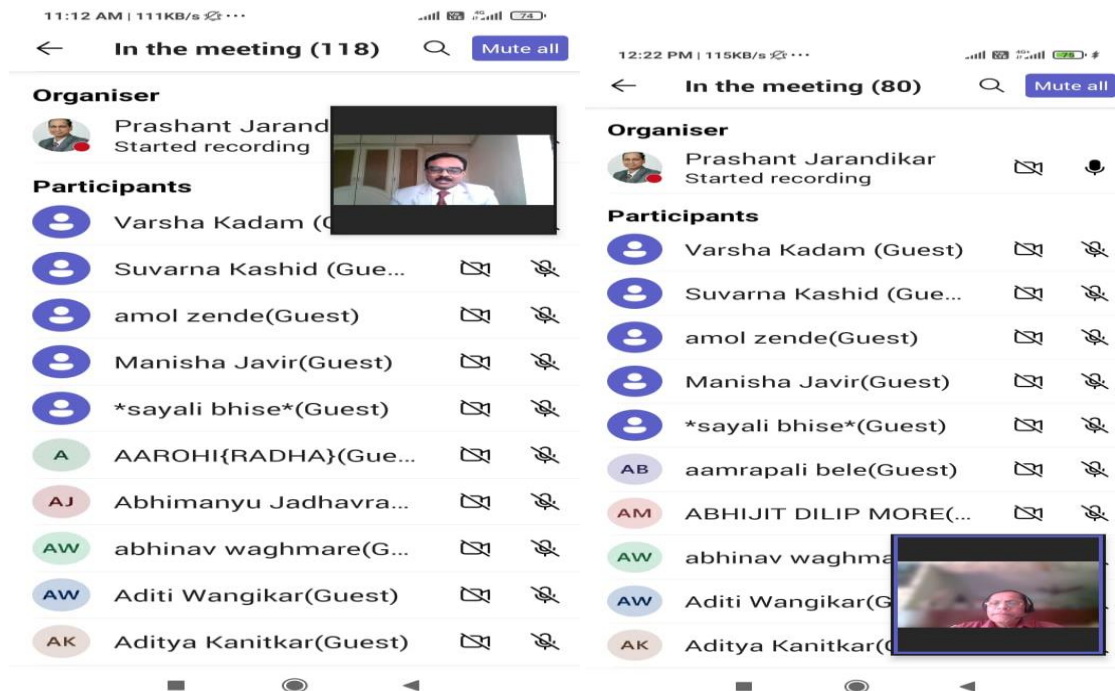

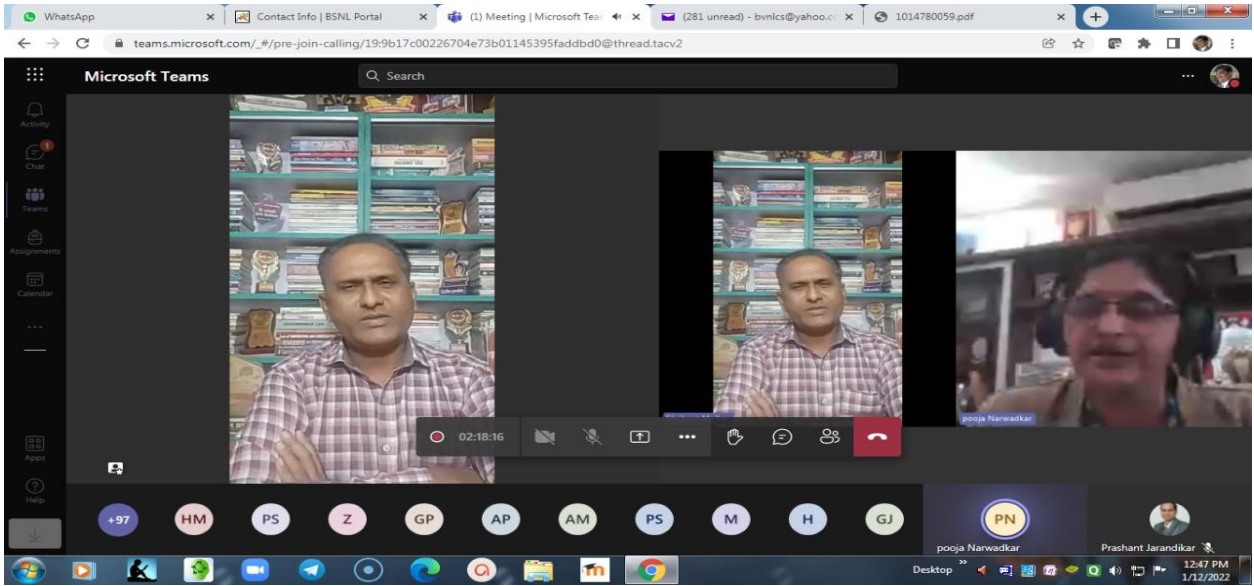

Report of the Online One Day Workshop held on 11 th January 2022

Topic: Woman in Contemporary India: Understanding issues and Challenges

Organized in Collaboration with

New Law College, Kolhapur

Yashwantrao Chavan Law College, Karad

On 11 th January 2022, Bharati Vidyapeeth's New Law college Sangli in collaboration with NewLaw College, Kolhapur Yashwantrao Chavan Law College, Karad organised the one day workshop on the topic **Woman in Contemporary India: Understanding issues and Challenges**. Dr.Swati Dyahadroy, an expert in gender studies, who working as lead researcher on various projects in Women's studies was the resource person of the first session of the workshop.

An adept researcher with decades of experience particularly in the fields of gender equality Ms. Deepa Tak was resource person for the second session of the workshop.

In her brief introductory note, Prof. Smita Adimani welcomed the guests and spoke about the general misconceptions people regarding gender and explained the aims and objectives for selecting this topic for the program. Prof. Adimani said that there has been an increasing need to make gender sensitisation at the ground level. The concepts of gender sensitisation and gender equality aim to fill the vacuum between idealism and reality.

In the first session, Dr. Swati Dyahadroy started her conversation on 'Understanding Gender in Contemporary India' with basic question, What is gender ?As per her view, gender is a social construct, a spectrum that forms the basis of how we view people and relationships. Over time, the inequality that has been normalized as a result of stereotypical

perceptions creates a hierarchy that deprives and oppresses certain stakeholders in it. She shared her valuable insights on the connection between gender equality and the law. She suggested the steps that should be taken to check gender inequality. She appreciated the college for organizing such workshop and added that it was a short introduction to the importance of gender sensitization and gender equality, the removal of gender biases at every step of the society, and including the voices of marginalized stakeholders to achieve lasting change. At the end question answer session was held. The students and teachers asked many questions and Dr. Swati patiently satisfied there queries. The first session ended with vote of thanks by our student Mr.Tushar Dhemre.

This mission statement was taken forward by Ms.Deepa Tak in the second session who presented the statistical data about Gender based Discrimination: Son preference or Daughter Aversion. She explained in details the laws introduced to stop female feticides. She stated that to establish that equality is not the sole mission of gender justice initiatives, but is also the primary mandate of education, especially legal education. She said that education is the key to break free from our social baggage that comes from caste, gender, and religion. In her argument using real-life, societal examples, such as how women are often seen in a unidimensional, problematic light – as victims or repositories of filial honour, which limits their potential and their power. She makes a connection between the invisibility of discrimination for a few as a direct product of their social privilege, which reinforces inequality and causes a ripple effect by creating ‘gaps’ in several important areas .

She hopes that through this workshop, all the participants can unlearn and challenge the narrow notions of the past to participate enthusiastically in an experience that reaffirms the position of women as free and independent citizens.

Principal, Dr.Pooja Narwadkar, in her presidential address talked about security issues .She said at present the security of women is at stake. She said that just making laws is not sufficient; but its stern implementation necessary .Moreover, legal awareness of women is need of the day to make them aware about their rights. She appreciated both the resource persons for presenting this severe issue in such simplistic way that student and their parents can understand it easily. Further, she appealed all the participants to think over this crucial topic seriously and step forward to stop gender discrimination .She said as a law student they should actively contribute to this social cause.

The event ended with a vote of thanks, delivered by our student Mr. Rajeshwar Singh. Prof. Shreyash Mohite, Mrs. Anita Patil and students of BVNLCS Ms. Soniya Nakil , Mr. Tushar Dhemre and Mr. Rajeshwar Singh were part of the coordinating team of the program.

Report Children's Day Competition 2021-22

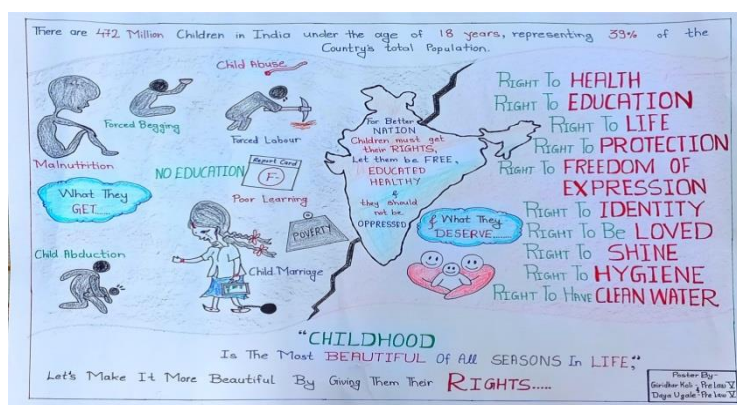

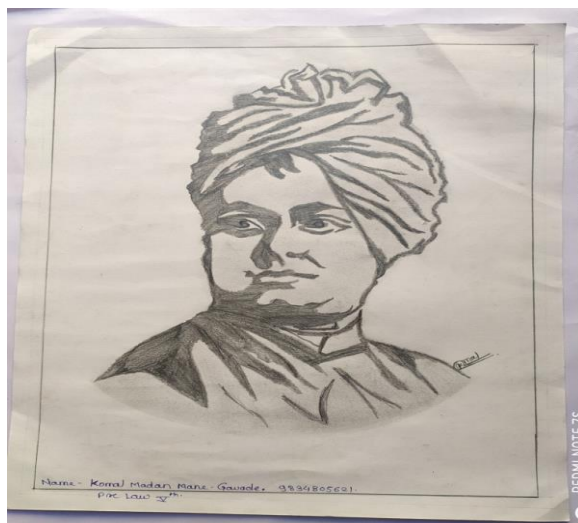

Our college, Bharati Vidyapeeth's New Law College Sangli has organized the Interclass Client Counselling Competition Wednesday, 18th May 2022 at 12:15 pm. The purpose of the Client Counseling Competition promotes greater knowledge and interest among law students in the preventative law and counseling functions of law practice. It also encourages students to develop interviewing, planning, and analytical skills in the lawyer-client relationship in the law office. Interviewing and advising are a significant part of most lawyers' work. Too often, it is assumed that lawyers have the listening and questioning skills needed to conduct an effective interview. The Competition provides an opportunity for a valuable educational and cultural interchange between students and law teachers.



Nature of the Competition

The Competition simulates a law office consultation in which two law students, acting as lawyers (attorneys/solicitors/legal practitioners), are presented with a client matter. The students conduct an interview with a person playing the role of the client. Students are expected to elicit the relevant information from the client, explore with the client his or her preferred outcome, outline the nature of the problem, and present the client with a means (or range of alternatives, if appropriate) for resolving the problem. The interview with the client is then followed by a post-consultation period during which the students, in the absence of the client, analyze the interview and discuss the legal and other work to be undertaken. The interview and post-consultation period last a total of 45 minutes. The students are evaluated by a judge. Once the judges have completed their evaluation of the interview, the students are called back in and the judges provide a brief critique of the team's handling of the consultation and post-consultation periods.

The participants for this competition were the students from Pre Law I to Pre Law V and LL.B. I to LL.B. III. We invited Adv. Prasad Kamble as a Judge for this competition.

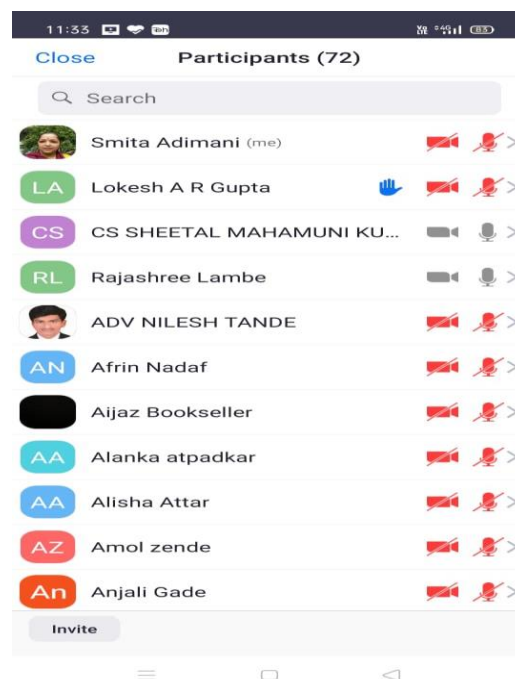
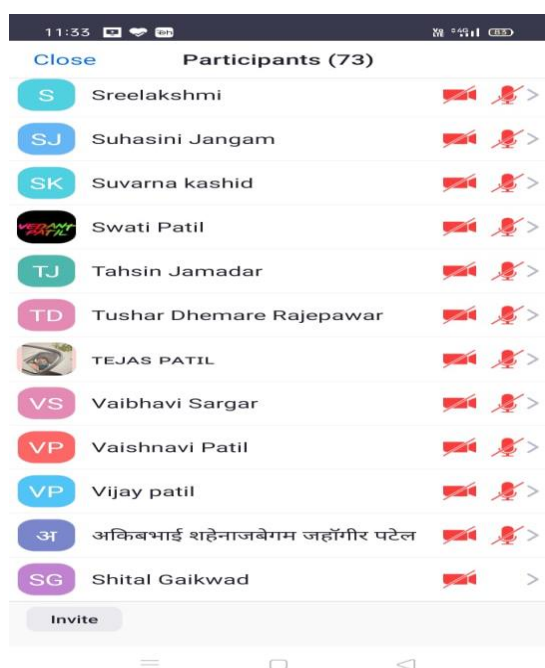
