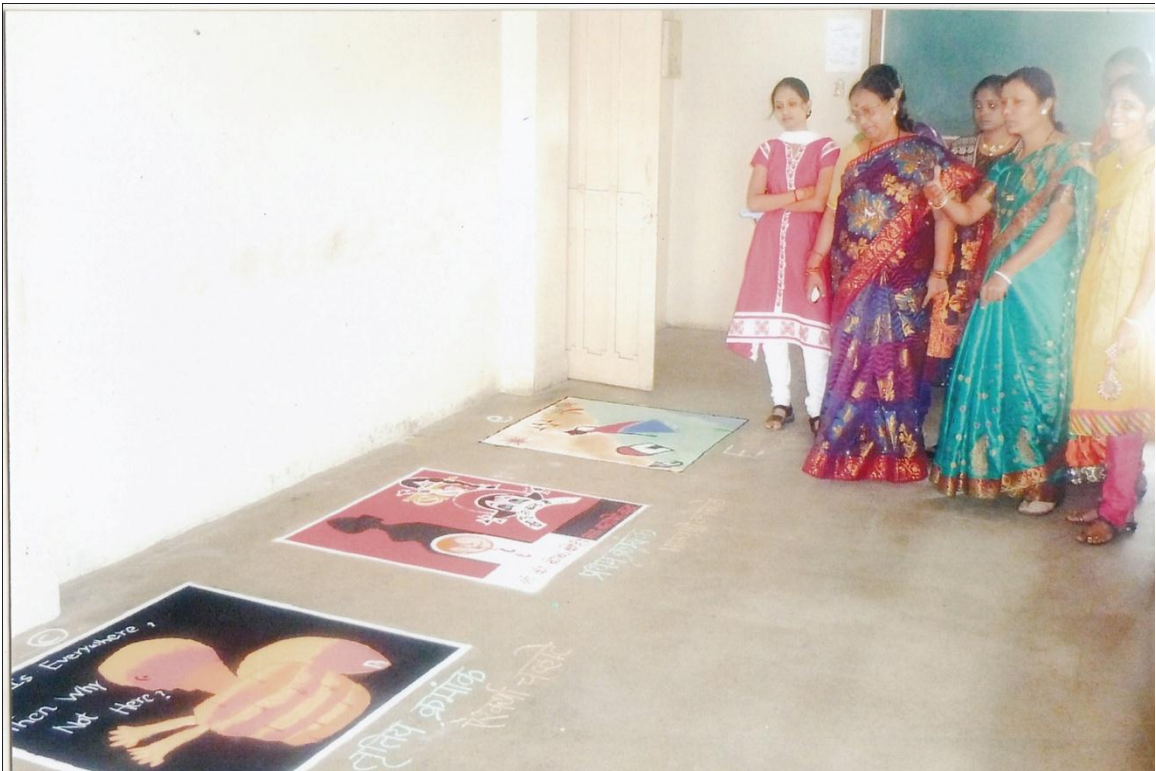




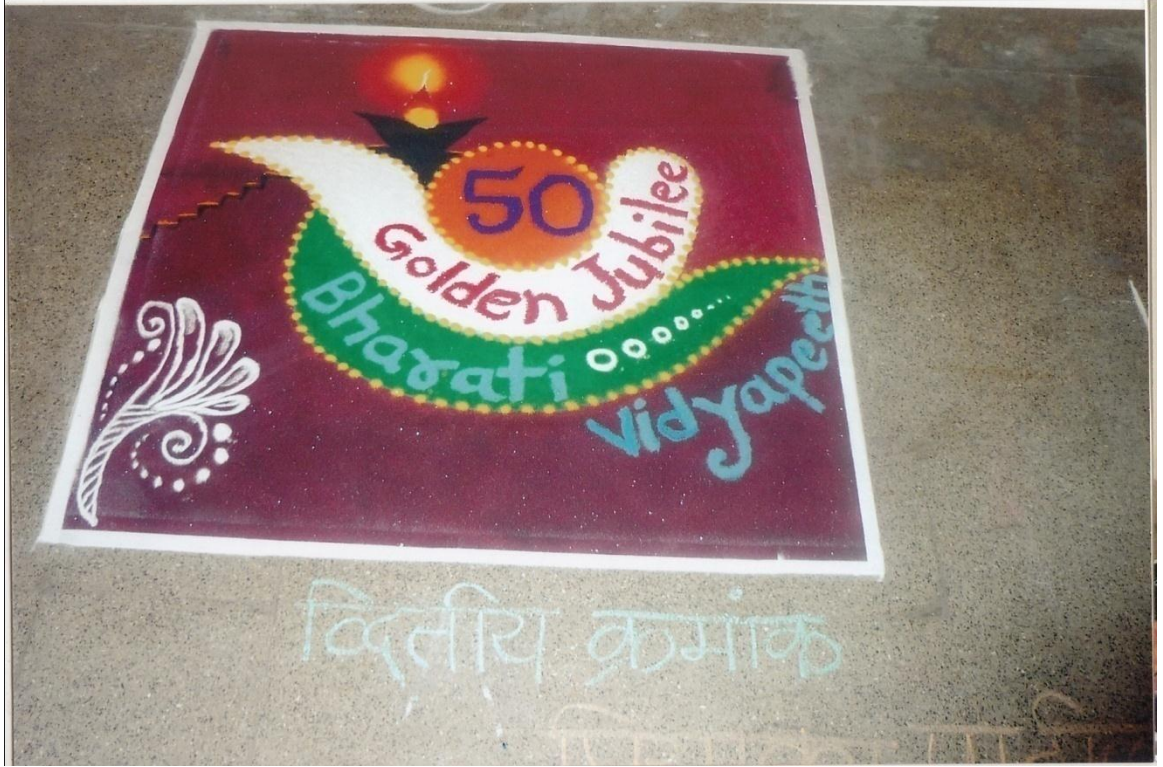
Rangoli Competition:
